




Digital MP3 CD Autoload System



Before using this unit, please read these operating instructions carefully. Afterwards, keep them handy for future reference.

Supplied Accessories



MP3 CD Autoload System Features

Integrated CD Autoload - drop in a CD, close the lid, and the unit automatically records the audio content from the CD to built-in memory or SD card.

USB Connectivity - transfer MP3 or WMA files directly to built-in flash or SD card.

On-Board Memory - unit comes with 128MB of on-board memory and is preloaded with nearly 3 hours of music content in a variety of styles. Choose to repeat one or all tracks.

Autostart After Power Interrupt - unit starts back into play mode when power is reapplied.

Save Settings Function - save track, playback mode and volume settings. Settings are retained even after power loss.

Digital Flash Memory - on-board memory retains music/message content even during power loss...unit ships with preloaded audio. Unit automatically starts in playback mode and retains track and volume settings after power loss.

SD Memory Card Slot - upgrade the MP3 CD Autoload System's memory up to 1GB (over 70 hours) by adding a Secure Digital Card (SD).

3 Repeat Options- unit supports repeat all, repeat all-shuffle & repeat one track functions.

Backlit LCD Control Panel - 6-line backlit LCD panel displays ID3 tags with descriptive track names for easy identification and selection. Display also shows a variety of important information so user can choose playback preferences and easily determine unit's operational status.


Firmware Upgradeable - Update the player's firmware from a PC via USB.

Built-In Monitor Speaker - allows user to monitor sound with the flip of a switch.

Wall-Wountable - unit can play while mounted in a vertical position.


Set-up

Audio Connection to PBX or KEY phone systems



- 1 Plug AC adapter into wall outlet.
- Plug AC adapter cable into jack marked "DC9V."
- **3** Plug "Connector Cable*" to "AUDIO OUT" jack.
- Plug other end of "Connector Cable" into phone system's music-on-hold (MOH) input jack. NOTE: If the jack cannot be located, contact your phone vendor for assistance.

Firmware Updates

Occasionally updates to the player's firmware are made available. These changes can include new features or bug fixes. The latest firmware updates are available at from your dealer.

- 1 Connect AC adapter to wall power outlet and plug power plug to the jack marked 12VDC.
- Plug USB cable (square socket) into the USB jack on the back panel of the player.
- **B** Plug the other end of the USB cable (rectangular) into the USB port on the back of the PC.

NOTE - To copy files to the player from your PC, see "Copying New Tracks to the Player" on page 5.


Your player's firmware version is displayed on the LCD when the player is powered on.

Updating firmware is a simple procedure that involves downloading a file from the site and connecting the player from the PC to the player via the provided USB cable.

Operation

Adding New Audio Using the CD Drive

The MP3 CD Autoload System will read ordinary Audio CDs and MP3 encoded CDs. Each time you record a new CD, the audio content stored on the on-board memory will be erased and replaced with the new audio from the CD.

Recording a CD

1 Place CD in the drive and close the lid.

- 2 LCD will show "CD READING" followed by "ERASING FILES."
- Recording will begin in real-time regardless of disc format (MP3 or Audio CD). Files recorded to memory will automatically be named Track01.mp3, Track02.mp3, etc..

When recording is completed, unit will automatically return to playback mode. NOTE: Audio recorded via the CD drive is sampled at 96kbps. At this rate the player can record 2 hours and 54 minutes of audio to the built-in 128 MB memory.

Recording a CD onto an SD Card

To record to an SD card, insert an SD card into the card slot on the right side of the unit, place CD in drive, and close the lid. When an SD card is recorded, the entire contents previously contained on the SD card is erased. After recording to the SD card, the unit will automatically go into playback mode.

NOTE: When recording to an SD card, the program content stored on the built-in memory is not erased. To play from the on-board memory, remove the SD card and press the **PLAY** button to resume playback.

Recording Time

Recording time via the CD drive is limited to around 2 hours and 54 minutes. This is more than enough to record an entire audio CD to built-in memory. If an MP3 CD containing over 2 hours and 54 minutes is inserted, the player will record as much of the CD as memory permits (2hr. 54 min. for built-in 128MB and up to 23 hrs. and 40 min. on a 1GB SD card).

Erasing Memory

The time that it takes to erase the memory varies from a few seconds to several minutes. The erase time is based on the number of tracks and the length of the tracks being erased. A row of diamond icons will show the progress of the erasure.



IMPORTANT

To prevent accidental recording of a CD, please remember to remove the CD from the drive once recording is completed. The player is designed to automatically record any CD in the drive to memory when the lid is opened and closed, or when power is turned off to the unit and then reapplied.



WARNING:

Recording a CD onto an SD card will overwrite the contents of the SD card. Make sure any important files are backed up!

Operation



Adding New Tracks to the Player via USB (Win)

Once connected via USB, the player will show up as two removable drives (i.e. Drive E & Drive F) in the MY COMPUTER window. The first drive will represent the on-board memory (128 MB). The second drive represents the built-in SD Card reader (only available if a card is inserted). The MY COMPUTER window is where you can manage the content on your player. From this window you can add/copy or delete files that are stored on your player.

Copying New Tracks to Your Player (Win)

- **1** Using the power switch on the back of the unit, turn the player off.
- **2** Plug the USB cable into the USB port on the back of your player.
- **B** Plug the other end of the cable into the USB port on your computer.
- Turn the POWER switch to the ON position (LCD will show an icon of a computer and a memory card with the word "READY").
- **5** Locate and select any MP3 or WMA audio file(s) or file(s).
- 6 Copy the files.
- **Z** Go to "My Computer" and double click on Drive E or F.
- 8 Paste the files to the selected drive.
- **9** Turn the POWER switch on the back of player to the OFF position.
- 10 Remove the USB cable and turn the player back to the ON position.

Adding New Tracks to the Player via USB (Mac)

Once connected via USB, the player (and SD Card, if inserted) will show up as a disc on your desktop. Copy, drag, or save the files to the drive. When completed, drag the drive(s) to the trash to unmount.

External SD Flash Card

The player is also equipped with a slot for a Secure Digital (SD) flash card. Files can be copied to the card by putting it into the unit and connecting the USB cable to a PC. Alternately, files can be copied to the card by connecting a smart media card reader to the PC's USB port and copying files directly to the card.

Using an SD Flash Card

The player has an SD card slot located on the right side of the player. Insert the flash card, label side up. When you insert an SD card, the files on the card will override the built-in memory. While the card is in the unit, you will not be able to see the tracks stored on the on-board memory.

About MP3 "ID-3 Tags"

MP3 files contain information "tags" that are displayed on the LCD (title, artist & album). Audio files transferred via USB or played via an SD card retain their tags. MP3 files put on a CD and recorded through the integrated CD drive will lose their tag information.



Playback Operation

Playback

Playing Audio Stored in On-Board Memory or on SD Card

By default, the unit is always in "playback" mode. When unit is playing, the LCD will display a running time and the ▶ icon will be shown on the LCD. Playback can be stopped by pressing the **PLAY/STOP** button.

Moving Between Tracks

While in playback mode, you can move between tracks by pressing the \checkmark buttons on the unit.

Fast Scanning Through Tracks

While in playback mode, you can fast forward or rewind through a track by holding the \checkmark or \checkmark button. When in Fast Scan Mode $\checkmark \checkmark \circ r \triangleright
ightharpoon will be displayed in the upper left of the LCD window.$

Playback Modes

The player is set to the PLAY mode as a default. You may stop playback by pressing **PLAY/STOP**. Using the button, you can select from one of three modes. The "repeat" icon in the LCD will show which mode you are in:

Repeat all tracks in order

⊂ S Repeat all tracks in a random order

1 Repeat the current track only

Selecting a Single Track for Playback

- 1 Press the **MENU** button (LCD will display track names)
- **2** Use the up/down arrows to navigate to the desired track.
- **B** Press the **MENU** button to select the track (a \blacklozenge will appear next to the selected track).
- Press the C button to return to playback -- the display will show 1

Saving Your Playback Settings

The unit can save volume level, repeat function, and track selection settings. To save settings follow these steps:

- **1** Press **PLAY/STOP** button once to stop playback.
- Press and hold PLAY/STOP again until the LCD shows "SETTING SAVED."
- Press **PLAY/STOP** again to resume playback.

Playback After Power Loss

If power to the unit is lost, the unit will automatically resume playback as soon as power is reapplied. If saved, volume level, repeat function and track selection settings are recalled as soon as power is reapplied and playback begins.



FCC Information

FCC Part 15

The REN is useful to determine the quantity of devices you may connect to your telephone line and still have all of those devices ring when your telephone number is called. In most, but not all areas, the sum of the RENs of all devices connected to one line should not exceed five (5).

The termination on an interface may consist of any combination of devices subject only to the requirement that the sum of the ringer equivalence Numbers of all the devices does not exceed 5."



Precautions

Installation

Never install the unit where it would be subjected to:

- heat sources such as radiators or air ducts.
- direct sunlight.
- excessive dust.
- moisture or rain.
- mechanical vibration or shock.
- unleveled surface.

• When the unit is used with an AC power adapter, do not wrap the unit in a cloth, blanket, etc. If you do so, the temperature inside and outside the unit may rise considerably, resulting in malfunctioning of the unit or serious accidents.

• For the unit to operate at its best, it should not be subjected to temperatures below 5°C (41°F) or above 35°C (95°F).

- To prevent fire or shock hazard, do not expose the unit to rain or moisture. To avoid electrical shock, do not open the cabinet. Refer servicing to qualified personnel only.
