

• Introduction

The T-21P is an audio coupler that was designed to play audio from an audio source, over a standard single POTS telephone line. It is used for applications such as: Voice Mail prompt recording, or playing pre-recorded messages or audio programs to customers on the phone. The audio source can be any audio device that has a headphone jack with an adjustable volume. It must have enough power to drive a standard stereo headphone set. Low power devices that were designed specifically for battery operation generally do not have enough power to drive the T-21P. Examples of audio sources are: CD Players, Cassette Tape Players, MP3 Players, and Computers with Voice Cards.

Operation

To **PLAY** audio onto the telephone line, start/stop the audio source at the appropriate time. Both you and your customer will be able to hear the message. In order to eliminate any background noise from the office, it is recommended that you use a telephone with a **MUTE** feature.

NOTE: The T-21P will NOT hold the telephone line; this means that you HAVE to stay on the telephone line while you are playing your audio.

• Recording or Monitoring of Telephone Conversations

While the T-21P was designed specifically to play audio over the telephone line, it can also be used to record audio from the telephone line. Please note that it is illegal to record, and/or monitor telephone conversations without notifying all parties that they are being recorded and/or monitored. The T-21P will allow recording of telephone conversations even when the telephone that is connected to it, is hung up. Illegal telephone recording and/or monitoring is a criminal offence.

ONE YEAR LIMITED WARRANTY


