



CK-1A Promotion-On-Hold Adapter (For AT&T 2462)

Introduction

Thank you for purchasing the Skutch CK-1A Promotion-On-Hold Adapter for the AT&T 2462 two line cordless phone system. The CK-1A is a true plug and play device. The unit does not require any "Learning" to operate. When a call is placed ON HOLD from the base set, or any one of the cordless phones, the caller will hear the Promotion-On-Hold audio. When the line is re-answered, the audio automatically stops. It's that simple!



Installation (1 Mod Cord)

1- Turn the phone upside down and connect the short modular cable from the CK-1A box to the AT&T 2462 telephone jack that is labeled "LINE 1/ L1+L2". (See Fig. 1).



2- Set the phone on the CK-1A box as shown in Figure #2.

3- Connect the audio cord from your audio source, to the AUDIO IN jack on the back of the CK-1 box. For DIGITAL units use the cable that comes with the player, not ours.



4- Connect a MOD cord from Telephone Wall Jack 1&2 to [1&2 Line on CK-1A], as shown in Fig. #3.

5- Locate the CK-1A "SENSOR BOARD", peel off the protector paper from the



bottom of the sensor board, and carefully place it OVER the LINE 1 and LINE 2 selection Push Buttons on the AT&T base set as shown in Fig. #4. Make sure the the holes in the back of the Sensor Board are directly over the lights on the buttons.

6- Connect the Sensor Cable to the Sensor Board as shown in Fig. #4. Make sure that the "Down" sticker on the "Sensor Cable" connector faces down.

7- Connect the POWER CUBE from the CK-1 box to 115VAC power. That's it!

Base Set Operation:


To select line one, simply press on the tab on the CK-1A sensor board labeled "1", then pick up the telephone. For line two press the tab labeled "2", then pick up the handset.

Installation (Two Mod Cords)

If your phone is installed with two telephone cords, one for line 1 and another for line 2, then you will have to use the enclosed adapter to convert the two separate cords to a single double line cord. Once this is done you can follow the Installation (Single Mod Cord) instructions.



Testing the System:

1- Pickup line 1 on your telephone. The No."1" LED on the CK-1A Sensor Board should light up. Hang up.

2- Repeat this test for line 2. If both lines light up when picked up, the CK-1A is working properly. If either light does not light up, then

- a) Make sure that the CK-1A and Telephone is connected to power.
- b) Make sure that the SENSOR BOARD is aligned properly.

Lights on CK-1 Box.

When you place a line on HOLD, the corresponding LED on the rear of the CK-1A box lights up to confirm the Promotion-On-Hold condition.

Using Other models of telephones

The CK-1A will ONLY provide Promotion-On-Hold audio when a call is placed ON HOLD from the AT&T 2462 base or any of its cordless telephones. Other models of telephones can be used with the AT&T 2462, but the Promotion On Hold audio will not be played to calls placed ON HOLD from these telephones.

ACTA Statement

This equipment complies with Part 68 of FCC rules and the requirements adopted by ACTA. On the bottom side of this equipment is a label that contains, among other information, a product identifier in the format US: AAAEQ##TXXXX. If requested, this number must be provided to the telephone company.

A plug and jack used to connect this equipment to the premises wiring and telephone network must comply with the applicable FCC Part 68 rules and requirements adopted by the ACTA. A compliant telephone cord and modular plug is provided with this product. It is designed to be connected to a compatible modular jack that is also compliant. See installation instructions for details.

The REN is used to determine the number of devices that may be connected to a telephone line. Excessive RENs on a telephone line may result in the devices not ringing in response to an incoming call. In most but not all areas,

the sum of RENs should not exceed five (5.0). To be certain of the number of devices that may be connected to a line, as determined by the total RENs, contact the local telephone company. For products approved after July 23, 2001, the REN for this product is part of the product identifier that has the format US:AAAEQ##TXXXX. The digits represented by ## are the REN without a decimal point (*e.g.*, 03 is a REN of 0.3). For earlier products, the REN is separately shown on the label.

If this equipment causes harm to the telephone network, the telephone company will notify you in advance that temporary discontinuance of service may be required. But if advance notice isn't practical, the telephone company will notify the customer as soon as possible. Also, you will be advised of your right to file a complaint with the FCC if you believe it is necessary.

The telephone company may make changes in its facilities, equipment, operations or procedures that could affect the operation of the equipment. If this happens the telephone company will provide advance notice in order for you to make necessary modifications to maintain uninterrupted service.
